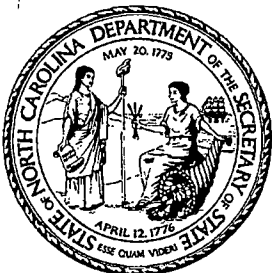
CERTIFICATE OF REINSTATEMENT
